⊕ The reservation between SC and ST is interchangeable i.e., if sufficient numbers of candidates are not available to fill up the seats reserved for SC candidates, this can be filled up from among suitable ST candidates and vice-versa as per merit. If eligible candidates are not found for reserved seats under PC category and it remains vacant, the same will be filled by the merit from General category. If the University does not find the candidate from OBC category, the OBC seats shall be converted into General category seats.

(*) Students of M. Tech. (Soil & Water Engg.) will have to go to other College Campuses of the University if land is not available for field experiments at Ranipool, Sikkim. Likewise, students of M.Sc. (Agri.) & M.Sc. (Hort.) may also be allotted to work at other College campuses of the University if Major Advisor is not available in that particular College where the student takes admission.

Eligibility Requirements:

- Indian Nationals having age not below 19 years as on 31.08.2017 (i.e., candidate should not have been born after 01.09.1998) are eligible to appear in the examination. No relaxation is admissible regarding the minimum age limit.
- Candidates with Bachelors' degree in concerned/related subjects from a recognized University with OGPA of 6.60/10.00, 3.25/5.00, 2.6/4.00 for General/OBC/UPS candidates are eligible for admission to the Master's Degree programmes. SC/ST/PC candidates with OGPA of 5.60/10.00, 2.75/5.00, 2.20/4.00 in the Bachelor's degree programme shall be eligible for the admission. In case where Grade Points are not awarded, only marks are awarded, the candidates must have secured at least 60% marks for General/OBC/UPS category and 50% marks for SC/ST/PC category. Candidates possessing 10+6 B.Sc. (Hons.) Agriculture degree shall also be eligible for admission to M.Sc. (Agri.) & M.Sc. (Hort.) programme.
- For in-service candidates also, qualifications remain same for respective categories.
- All the candidates should produce the original Provisional Degree certificate issued by the University at the time of counseling, failing which their candidature will not be considered for admission. The candidates claiming reservation under SC/ST/OBC/PC (40%) categories should produce original certificate issued by the competent authority in support of their claim without which claim for reserved seats will not be entertained.

How to Apply:

The applications on white paper (A4) as per appended APPLICATION FORMAT (Appendix - I) along with attested copies of certificates, mark sheets, age proof certificate, domicile certificate, OBC/Caste/Tribe/Physically Challenged certificate (if required) and a non-refundable application fee of ₹ 1000/- (Rupees one thousand only) for General/OBC/In-service candidates and Rs. 500/- (Rupees five hundred only) for SC/ST/PC candidates in the form of IPO or Demand Draft drawn in favour of the Comptroller, Central Agricultural University, Imphal payable at the SBI (Main Branch), Imphal should be sent so as to reach the Office of the Registrar, Central Agricultural University, Lamphelpat, Imphal - 795004, Manipur on or before the 15th July, 2017. (University will not be responsible for any postal delay). Candidates willing to appear written test for both M.Sc. (Agri.) and M.Sc. (Hort.) programmes should submit separate application forms. Candidates have to appear for the Entrance Examination and counseling as per the schedule given below.

Candidates from the Govt. Departments/Organizations are required to submit his/her application through the Head of Department concerned, failing which the candidature will not be considered.

The Selection of candidates will be based on the Entrance Examination marks (40% weightage) and academic performance in qualifying Degree Examination (40% weightage), High School (10% weightage) and Senior Secondary (10+2) (10% weightage) Level Examinations. Entrance Exam & Counseling Centre for all the above PG Programmes will be held at College of Post-Graduate Studies, Barapani, Meghalaya as per schedule given below.


