5. Rate once quoted shall remain valid for 3(three) years which can be extended on mutual consent.
6. The expiry date of supplied medicine should not be less than 6(six) months from the date of supply
7. The tender will be evaluated on the basis of discount on MRP offered by the bidders.
8. **The contract for supply of medicines will be awarded to the supplier who offered maximum discount on MRP. Discount on MRP to be offered separately for Branded medicines & Generic medicines in the quotation.**
9. Medicines to be supplied to the medical unit, College of Fisheries, Lembucherra within 10 (ten) days of receipt of the supply order.
10. The undersigned reserves the rights to accept or reject any tender including the lowest one without assigning any reason thereof.
11. Payment will be made by cheque on submission of bill after satisfactory delivery of the medicines.
