TERM & CONDITIONS OF TENDER:

1. The rate quoted should be firm & fixed for a **period of one year and rate to be quoted both in figure and word and in round figure** failing which the tender will be rejected,
2. All correction to rates/otherwise in the quotation shall be initialed by the tenderer. Every page including the blank pages of the quotation shall be signed by the tenderer.
3. A Contract agreement for one year on non judicial stamp of Rs 100/- shall be executed with the successful tenderer. The cost of the stamp and other clerical charges if any shall be borne by the Contractor.
4. The agreement to be made initially for 1(one) year and performance to be reviewed in time to time. In case of satisfactory performance the contract may be extended further period of time under mutual consent.
5. In case of any dispute in the rate or otherwise the decision of the college authority will be final and binding.
6. Any dispute arising out this agreement shall be referred for arbitration to the Registrar, Central Agricultural University, Imphal and the decision/award of the arbitrator shall be final and binding on both the parties.
7. In case any request/letters etc. are found along with the quotation requesting for favor or otherwise the candidature of the tenderer straight way cancelled and tenderer shall be black listed for further participation against the college tender.
8. Earnest money deposit (Refundable) **Rs. 3000/- (Rupees three thousand)** in the form of **Demand draft/Banker's cheque** drawn in favour of "**Dean, College of Fisheries, Lembucherra**" should be enclosed with the quotation failing which the quotation shall be summarily rejected. EMD of the un - successful tenderer shall be returned on completion of the tender process. No interest will be paid on EMD.
9. In case Tender documents downloaded from the web-site the cost of the tender forms **Rs.500/-** in the form of **Demand draft/Banker's cheque** drawn in favour of "**Dean, College of Fisheries, Lembucherra**" should be submitted with the quotation **separately** failing witch the tender will not be considered.
1. **Performance security Rs. 10,000/- (Rupees ten thousand)** only is required be submitted by the successful tenderer before execution of agreement .This Performance security will retained by the college till the contract period is exists. No interest will be paid on Performance security. Performance security will be forfeited if the successful tenderer fails to supply the vehicle when demand for supply. Such performance shall be taken into record and will be debarred from dropping tender in future.
10. Income tax and other statutory deduction (s) shall be deducted from the bill and payment to be made through cheque only .
11. The supplied vehicle should not be of '**MAKE**' **prior to 2014** & should be in good condition. Only '**Good Condition Vehicles**' will be used by the College. The registration, insurance of the vehicle etc. to be updated and valid.
12. The driver deployed for duty should be polite and having good character with good driving records and having valid driver licensee etc.
