1. The tender must be supported by:
 - a) Make, Model No, Brand of the 5 KVA Online UPS with detailed specification and catalogue of the manufacturer.
 - b) Authorized Dealership/Warranty Certificate/Agency certificate of the principal manufacturer and up to date Income Tax/Sales Tax clearance certificate.
2. The tender shall be further subject to:
 - a) Rate shall be FOR destination (College of Fisheries, Lembucherra) an inclusive of all taxes etc.
 - b) Rate once quoted shall remain valid for 1(one) year which can be extended on mutual consent.
 - c) After sales service has to be provided by the successful tenderer. A consent certificate to that effect has to be submitted by all bidders with the quotation.
 - d) The quotation should be accompanied with an **Earnest Money Deposit @ 2%** of the quoted price by Demand Draft/Banker's Cheque drawn from any Nationalized banks in favor of the "**Dean, College of Fisheries, Lembucherra, Tripura**", payable at Agartala.
 - e) EMD of the unsuccessful bidders to be returned at the earliest after finalization of Tender. If the successful bidders fail to execute the supply within the stipulated time the EMD amount will be forfeited. (No interest is payable against the EMD).
 - f) The undersigned reserves the right to accept or reject any tender including the lowest one without assigning any reason thereof.
 - g) Performance Security an amount of 5% value of order to be deducted from the bill as Performance Security (Security deposit) and should remain valid for a period of sixty days beyond the successful supply and execution of the job. (No interest is payable against the Performance Security/Security deposit).
 - h) Payment to be made to the supplier by A/C Payee cheque on submission of the bill after delivery of the items as per specification and completion of successful installation and demonstration.
 - i) In case of any dispute the decision of the College authority will be final and binding.
 - j) **Supply order shall be executed within 10 (ten) days of placing the order.**
